### [Animal Welfare Initiatives in Japan](#)

Dr. Jeff Rushen, Agriculture & Agri-Food Canada (AAFC), has kindly shared his communications with Japanese counterparts on Japanese initiatives in farm animal welfare. The information provided by Professor Shusuke Sato, PhD (Graduate School of Agricultural Science at Tohoku University, Japan) is summarized below.

- The Japanese government established an 'exploratory committee' on animal welfare developments within the OIE & Europe two years ago
- The committee has developed a report (May 2007) with the following 4 recommendations:
  - o Japanese animal welfare guidelines need to take Japanese culture, climate and ethics into account
  - o Consideration needed of the balance between animal welfare and economics
  - o Respect for farm animals and pet animals should be considered separately
  - o Animal welfare guidelines and agriculture law need to be harmonized
- The committee will be responsible for developing animal welfare guidelines for laying hens, pigs, broilers and cattle over the next 4 years (2007 – 2010). Cages systems for laying hens and gestating sows will be considered first. Rearing systems for cattle (including dairy) will be addressed later (2009 – 2010).
- Korea is moving in the same direction. Prof. Sato has connected with Korean animal welfare scientists.
- Prof. Sato requested a copy of the Canadian dairy code. Dr. Rushen referred him to NFACC's website.

Massey University's Animal Welfare Science and Bioethics Centre has been recognized as a Collaborating Centre of the World Organisation for Animal Health (OIE). It is one of two Collaborating Centres for animal welfare, the other being in Teramo, Italy. Press release:

#### DEFRA responds to Farm Animal Welfare Council's report on the welfare implications of animal breeding and breeding technologies

The UK Department for Environment Food and Rural Affairs (DEFRA) “accepted or partially accepted several of FAWC’s eight recommendations, including that surveillance systems should be established to monitor on-farm welfare problems associated with breeding, and to monitor farms where new breed types or new breeding technologies are first introduced into commercial practice.”

Of the 8 recommendations, 1 was accepted, 3 were partially accepted and 4 were rejected. Rejection rationale included: current legislation is addressing the proposed recommendation, an EU-wide breeding Code is in place, and the breeding industry recognizes the importance of animal welfare.

#### Wendy's strengthens animal welfare guidelines

Wendy's International Inc. says it will preferentially buy from pork and chicken suppliers who improve systems for humane animal welfare by:

- encouraging suppliers to eliminate gestation stalls and preferentially-buying from suppliers who adopt these plans;
- purchasing preferentially from approved suppliers who actively explore and test Controlled Atmosphere Stunning (CAS) systems.
